Important Note:

1. Tuition fees are made in 3 payment terms for each academic year. All fees are to be paid before the commencement of each term.
2. School uniforms, books, meals, certain specialised after school activities and field trips are NOT included in the tuition fee and will be invoiced separately.
3. All external exam fees are borne by students.
4. Late payment charges of two percent (2%) per month will be levied, which is calculated on a daily basis from the payment due date.
5. Deposit is non-transferable but refundable, subject to compliance with the Withdrawal Policy. The deposit and all fees paid upon confirmation of enrolment will not be refunded or shall not be transferable if the student does not attend Sri UCSI School thereafter after being confirmed an admission. This security deposit shall be forfeited if the admission is not taken up.
6. Fees are subject to yearly increase. Sri UCSI School reserves the right to review its fees with not less than 1 term's notice.
