- Three terms are offered in one academic year. Tuition Fees and Misc Fees are to be paid before the commencement of each term.
- The above fees do not include school uniforms, books, meals, personal insurance, certain specialised after-school activities, and field trips, which will be invoiced separately. Miscellaneous fees are for coaching fees, theatre, field trip, curriculum materials, digital platforms, library resources, and IT infrastructure.
- It is mandatory for students who are enrolled in Standard 6 and Form 3 to register for Cambridge Checkpoint exams. The exam fees in Year 2027 are RM780 and RM930 respectively, and subject to annual increase.
- Late payment charges of two per cent (2%) per month will be levied, which is calculated on a daily basis from the payment due date.
- All external exam fees are borne by students.
- The deposit is refundable, subject to compliance with the Withdrawal Policy. The deposit and all fees paid upon confirmation of enrolment will not be refunded or shall not be transferable if the Student does not attend School thereafter after being confirmed an admission. This security deposit shall be forfeited if the admission is not taken up.
- Fees are subject to yearly increases. Sri UCSI School reserves the right to review its fees without prior notice.
